RESOLUTION NO. 2006 - 072

RESOLUTION CREATING AN AD HOC COMMITTEE FOR THE PROTECTION OF THE RIGHTS AND WELFARE OF THE CHILDREN IN MURCIA AND PROVIDING FOR ITS COMPOSITION.

WHEREAS, it is the policy of the state to defend the right of children to assistance and special protection from all forms of neglect, abuse, cruelty, exploitation and other conditions prejudicial to their development;

WHEREAS, the state recognizes the vital role of the youth in nation building and shall promote and protect their physical, moral, spiritual, intellectual and social well-being. It shall inculcate in the youth patriotism and nationalism and encourage their involvement in public and civic affairs.

WHEREAS, this Municipality adheres to support the policies to their fullest extent and thereby agrees to create the so called ad hoc monitoring committee to perform as fact finding team about the plight of children working in the fields and industries prejudicial to their physical, social, moral, spiritual and educational well-being found within this Municipality.


